If an item you are selling is suspected to not be handmade, we will ask that you remove it from your booth. This is solely at the discretion of the Green Market committee.

The fee for single Saturday is \$10.00 (payment made on the Friday before Market or the day of Market is \$15.00). Payment up front for the whole season (NOT including RED Green Market) is \$60.00. Anyone selling 90% fresh produce may participate for free. Green Market fees are non-refundable. Please mark the dates you will participate at Green Market:

Item(s) you will sell at Green Market.

- May – October Market hours are 8:00 – 2:00. April Market is held with the Crossroads Chili Cook-Off and will be from 8:00 – 5:00.
- You MUST be set up by 8:00 and you MUST stay until Market is over or your participation will be revoked for future markets.
- No reserved spots. Green Market booths are on a first come basis. Tents may not be set-up prior to Market days. No exceptions!
- No parking is allowed in the lot beside Green Market. If you do not move your car after you unload and before Market begins, your vehicle will be towed at your expense.
- Sales tax will be collected from each seller at the end of the day.
- If you are selling any food or baked goods (excluding fresh produce), please be aware of health department regulations before signing up.
- There are no refunds, exchanges, rollovers, or rain checks for any reason.
- Sellers must keep all merchandise within the confines of their 10x10 space booth at all times. Aisles should be clear.
- All sellers agree to leave their booth free of trash and debris at the end of the show.
- Please note that the holiday RED Green Market is NOT part of the regular season and will require a separate application and a separate fee.
- Sellers are responsible for providing their own table, chairs, canopies, etc. There is no electricity provided and no generators are allowed.
- No literature or printed material of any kind may be distributed to sellers or customers without prior consent of Green Market. Green Market is a solicitation free zone!

All authorized vendors participating in the Green Market at the Corinth Depot shall be individually and severally liable to the CACVB for any loss, bodily or personal injury, deaths, and/or property damage that may occur as a result of the vendor's negligence or that of its servants, agents, and employees. All vendors hereby agree to indemnify and save the CACVB, its officers, directors and employees harmless from any loss, cost, damages, and other expenses, including attorneys' fees, suffered or incurred by the CACVB by reason of the vendors' negligence or that of its servants, agents and employees; provided that the vendors shall not be responsible nor required to indemnify the CACVB for negligence of the CACVB, its officers, directors or employees.
